## ACO members

Over 100 registered charities, all independent and seeking to raise their profile and help more people.

ACO members make grants to many hundreds of thousands of people each year offering them support, advice and befriending. Over £150 million is given annually in grants alone.

Our members are set up to help a broad range of people, potentially the 12.5 million people in the UK with less than 50% of average income. There are also eligible people overseas.

## Membership benefits

### Newsletter

Free newsletter published ten times per annum. Packed with up to date information and the latest guidance specifically tailored to organisations that give grants and welfare support to people in need.

The newsletter is sent to every email address within your organisation at the beginning of the month. A free sample copy is available on request.

### Meetings

Members can attend a range of meetings and networks free of charge. This includes the Grant Making Forum and Under Fives Group (for solo workers and small staff teams). ACO organises regular one off meetings on specialist areas.

### Annual Conference

Once a year ACO organises a national conference featuring keynote speakers and expert-led workshops, bringing members together and promoting best practice in grant making and welfare support.

### Lobbying and Campaigning

ACO represents member's views on issues of concern to government, opinion formers and policy makers. We lobby to promote a better public understanding of benevolence: the giving of time and money to help people in need.

### Better Together

ACO develops projects in partnership with members to encourage collaborative working. Recent groups have included a project for organisations working internationally, an impact group and a PR campaign to raise public awareness of the work of ACO members.

### Online Support

Members get exclusive access to Benepedia, the ACO knowledge website that contains briefings on policy and practice, a research library and an on-line forum.

<b>Band A Subscription:</b> For organisations with an annual turnover between £1m and £3m	<b>£790</b>
<b>Band B Subscription:</b> For organisations with an annual turnover between £3m and £5m	<b>£890</b>
<b>Band C Subscription:</b> For organisations with an annual turnover over £5m	<b>£995</b>
<b>Low Income Subscription:</b> For organisations with a low income and subject to approval by the Treasurer.	<b>£370</b>
